## **Rendezvous in Mackinaw & 18<sup>th</sup> Century Market Fair Event Information**

All participants are welcome and encouraged to arrive on site between the hours of 12:00 Noon, and 10:00 p.m. Thursday, August 5<sup>th</sup> & Friday, August 6<sup>th</sup>. Please note that all vehicles should be removed from the merchant area as soon as you are set-up to help eliminate congestion and allow parking for the public. There will be a participant parking area.

Merchants may open Thursday evening if they wish. Public hours will be 10:00 a.m. to 5 p.m. Friday and Saturday and 10:00 a.m. to 4:00 p.m. Do to the nature of the tourists in the Mackinaw City area, merchants and blanket traders may stay open for business if they choose to until dusk, Thursday, Friday and Saturday evenings.

Vehicles may re-enter encampment at 4:00 p.m. Sunday to break down camp and load.

There will be no pets allowed in the encampment unless they are service animals.

All participants should be in period attire and use period shelters and equipment. Please keep modern intrusions to a very minimum. It is the purpose of this event to provide an enjoyable period atmosphere. Modern anachronisms distract from the atmosphere and sanctity of the site. Please help by policing your own area.

Water and Porta-johns will be located adjacent to the encampment and merchant areas.

Firewood as provided will be located in the encampment area. Please keep garbage out of sight at all times, refuse barrels will be located throughout the encampment.
